Course Description

Organizations need employees who can help senior executives identify and prioritize strategic issues and then launch and execute projects to accomplish strategic objectives. Also, the field of Strategic Improvement continues to evolve with the integration of Lean and Six Sigma, the growing importance of Innovation, and the emergence of Analytics and Big Data. A *Strategic Improvement Black Belt* possesses knowledge and skills in these and other areas. One of the *best practice* project approaches is *Lean Six Sigma*. This approach combines the "waste out" Lean techniques with the structured Six Sigma problem-solving method and tools to provide leaders with a way to improve efficiency and effectiveness. This ten day *Strategic Improvement Black Belt* course prepares participants for this role through nine days of application-oriented training, practical assignments, project work, a final presentation, and a rigorous final exam. Participants will take their *Strategic Improvement* expertise to the *next level* by completing this course and prepare themselves for the *Strategic Improvement Master Black Belt* level of mastery.
